Charity Staffing

Infosound employed one part-time member of staff throughout 2024 to oversee all aspects of Infosound's work, in terms of supporting other charities and organisations in their production and distribution of audio content for the benefit of blind and partially sighted people, in launching the charity's new audio transcription service and in administering the day-to-day running of the charity.

Remuneration for these roles was ceased at the end of 2024, with this work being undertaken on a voluntary basis by the same person as from 1st January 2025.

Governing document

The Association is a charitable unincorporated association and the purposes and administration arrangements are set out in our constitution.

Charitable purposes

The charity's purposes, as recorded in our constitution, are to serve the needs of any person resident in the United Kingdom who is blind (severely sight-impaired) or partially-sighted (sight-impaired) or labouring under some temporary or permanent incapacity or disability which makes reading print material inaccessible to them, by the provision of information in audio and other accessible formats.

Activities and achievements

2024 marked a useful and productive transition year for Infosound, changing from its role as a producer of information in audio to that of a support service for any charity or organisation wishing to make their own information easily accessible to blind and partially sighted people.

This change in direction allowed our staff and volunteers to directly, and indirectly, share the knowledge they had acquired over thirty years in this field by advising, training and offering practical support to anyone needing information to be produced in accessible audio.

Later in the year, another service was added to the charity's portfolio as, for the first time, Infosound started to audio transcribe others' print or online material - that is, recording their text as audio. In keeping with Infosound's charitable puposes, the aim was to increase accessibility to written material for those with little or no sight.

As more and more information is being placed only online, it is often being placed beyond the reach of many who are unable to read, through sight loss. Our Trustees therefore felt help was urgently needed to address this problem; and the charity was re-tasked accordingly.

This new work enjoyed a promising start in the second half of 2024, not least by continuing to work in close partnership with the UK-wide charity The Partially Sighted Society, turning their written material into the spoken word. Our trustees feel confident there is a growing need for this service, which it is hoped will increase during 2025.

Trustee remuneration and expenses

The trustees did not receive any remuneration or expenses during the year.

Financial review and reserves policy

2024 proved to be the most difficult year, so far, for Infosound's fundraising efforts, with many past donors appearing to choose to awards grants to new areas, rather than to causes supporting those with vision impairment.

Raising just £5,665 during the year, this fell far below the minimum £10,000 target for the year.

As a result, the charity was unable to make capital purchases - in particular a new main studio computer. Also, plans to employ a professional software designer to expand and improve our Alexa presence as an accessible way to deliver information through voice-only control, was put on hold.

The decision was also made for Infosound to cease being an employer and become an all-volunteer charity as from the start of 2025, since it was felt our committed and experienced volunteers would be able to manage all necessary tasks.

The trustees were pleased to note that the day-to-day running costs have again been maintained at a sustainable level. In addition, firm plans have been put in place to seek assistance from other vision-impairment-related charities to bolster our fundraising efforts in 2025, to build back our reserves and to give Infosound the ability to expand its support services to meet demand.

Medical Insurance Scheme account

Infosound runs a private group medical insurance scheme, currently offered by medical insurers WPA, which is available to the charity's Trustees, staff and volunteer members who wish to join. It is run on a zero-balance basis with group members paying their individual premiums to Infosound, which in turn pays WPA for the annual group premium. In this way, there is no cost to the charity for running this scheme and no benefit-in-kind offered to scheme members.

This scheme is run entirely separately from the charity's work and accounting and all funds are held in a separate bank account from the charity's operational current and savings accounts, with premiums being collected into, and paid out from, this designated account.

Independent Examiner's Report to the Trustees of Infosound

I report on the accounts of the charity for the year ended 31 December 2024 which are set out on pages 3 to 4.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records.
